

**TENDER NOTICE  
FOR CONSULTANT SERVICES**


Sealed single stage--- two envelopes bids (Financial and Technical proposal) in separate envelopes to avoid confusion are invited from eligible Consultants for the project titled "Construction of FC Training center Michni, Shabqadar (Phase-II)" up to 22-10-24 at 1200 hours. Technical bids will be opened on the same date at 12:30 hours in the Committee Room of FC Headquarters, Peshawar, while financial bids of the qualified bidders will be opened later. Qualified bidders will be notified accordingly.

• **Scope of work includes:**

1. Detailed soil investigation and preparation of geotechnical report.
2. Survey, preparation of site plan and master plan of the scheme
3. Preparation of detail presentation with 3 Ds of individual building and entire complex for necessary approval of the competent authority
4. Preparation of detail architectural construction design
5. Preparation of detail structural design
6. Preparation of electrification/ Plumbing, sewerage & sanitation system design
7. Preparation of solar design for the entire project
8. Preparation of detail specifications and detail cost estimate
9. Any other detail required under this project

• **Selection criteria:**

- i. Consultants must have a valid registration with Pakistan Engineering Council (PEC) and Pakistan council of Architect
  - ii. Consultants must have a valid registration with income tax department
  - iii. Consultants must have design similar projects
  - iv. List of technical staff with qualification and experience
  - v. List of tools of equipment.
  - vi. List of completed project in last five years and list of in-hand projects
  - vii. Any litigation in respect of projects( list and decision)
  - viii. A affidavit that the firm is not blacklisted shall be attached with the documents

  2. Initially one envelop (Technical proposal) shall be opened.
  3. The envelope marked as "financial proposal" shall be retained in the custody of the procuring agency without being opened.
  4. During technical evaluation, no amendment in the technical proposal shall be permitted.
  5. Financial proposal of bids shall be opened publically at a time, date and venue announced and communicated to the bidders in advance
  6. The bidders will quote the cost in words and also in figures.
  7. The undersigned reserves the right to accept or reject any or all bids/proposals under the clause 33(1) as envisaged by PPRA rules 2004, **WITH OR WITHOUT REASON.**
