


TENDER NOTICE

Sealed single stage--two envelopes bids (Financial Proposal and Technical Proposal) in separate envelopes to avoid confusion are invited from Government approved (G.S.I registered authorized dealers/Agency) for Purchase of Tyre / tubes and Batteries for FC Vehicles for the year, 2022-23. These must reach this HQRs up to 27/10 /2022 at 11:00 hours, which will be opened on the same date at 11:30 hours in the presence of bidders by purchase committee in conference room of CHO, Peshawar. Bid Security / CDR@ of 2% of total value of each items must be submitted with tender (Technical /Financial Proposal) in the name of **Commandant, Frontier Constabulary, Khyber Pakhtunkhwa, Peshawar.**

TERMS AND CONDITIONS:-

1. Bidding documents/Technical Specifications of Tyres / Tubes and Batteries for FC Vehicles can be obtained from the office of the undersigned.
2. Initially only one envelop (TECHNICAL PROPOSAL) shall be opened.
3. The envelop marked as "FINANCIAL PROPOSAL" shall be retained in the custody of the Procuring agency without being opened.
4. The procuring agency shall evaluate the technical proposal in a manner prescribed in advance without reference to the price and reject any proposal which does not conform to the specified requirements.
5. During the Technical evaluation, no amendments in the technical proposal shall be permitted.
6. After evaluation and approval of the technical proposal, the procuring agency, shall at a time within the bid validity period, publicly open the financial proposals of the technically accepted bids only.
7. Quoted prices must be inclusive of all taxes applicable.
8. The financial proposal of bids shall be opened publicly at a time, date and venue announced and communicated to the bidders in advance.
9. Under the clause 33 (1) in the PPRA Rules 2004 "The procuring agency may reject all bids or proposals at any time prior to the acceptance of a bid or proposal.
10. **The rates approved shall remain valid till 30th June, 2023.** Only typed on original letter pad, sealed in a manner that cannot be known until opened and signed (every page) should be submitted. The bidders will have to submit their address; land line phone number. Taxes will be charged as per rules.
11. An affidavit on stamp paper that the firm is not blacklisted shall be attached with the documents.
12. The successful firm/ bidder will deposit Bank Guarantee @ 10% of the cost of the order as refundable security at the time of receipt of confirmed orders along with a judicial stamp paper for contract agreement.
13. Minimum 01 Year guarantee will be given by the firm for the supplied items, starting from the date of issuance from store, any item found defective will be replaced without cost by the supplier within 07 days of notification. The CDR will be returned on due completion of the contract and warranty / guarantee period.
14. The payment will be made after the stores are received checked and then the bills will be passed.
15. The store rejected will be collected by the supplier at his own risk/ cost within 07 days of receipt of intimation.
16. The successful firm will have to sign an agreement on judicial stamp paper according to the Government instruction regarding to stamp duty on instruments.
17. All the contractors should bring their own samples according to the specification.
18. The items offered must be compatible with the existing system.
19. The sample provided must be in pairs so that proper technical evaluation may be done on them.
20. The rate should be quoted on F.O.R basis HQRs Frontier Constabulary, KP, Peshawar including all taxes.
21. Quotations received without samples will not be accepted, any firm submitting quotations without sample will also lose their chance of competition in respective bids.
22. The firm's name and trade mark should not be written on samples. Only tags bearing firms names should be attached.
23. No advance payment will be made by Frontier Constabulary.
24. Bidding documents received through fax will not be acceptable. Tender with incomplete supporting documents will not be entertained and furnishing of incorrect/false information shall be liable to legal action. This tender is also available on PPRA website www.ppra.org.pk as well as on Frontier Constabulary Headquarters Peshawar website www.fc.gov.pk
25. All bids and proposal are supposed to be opened in presence of respective bidders as per rules. If a bidder is not present at the time of opening of proposal or bids etc, his documents will not be considered and opened.
